

Application for Conference Grant

The Conference Grant is intended to subsidize HKES members to attend conferences, seminars, workshops or similar activities in the areas of human factors and ergonomics. A maximum of HKD 5000 may be granted. The society will not grant retroactive approval for activities that have passed. The applicant, at time of application, should be a member of the HKES. Applications will be considered twice every year. Preference will be given to conferences such as the IEA, and annual conferences of HFES and UK Ergonomics Society. The deadlines are 30th April and 31st October. An applicant will be informed of the outcome of their application within approximately 8 weeks after each of the above deadlines. Each applicant can only submit a maximum of one application every year. The Society decision is final with regard to the award or lack of award of the above conference sponsorship.
